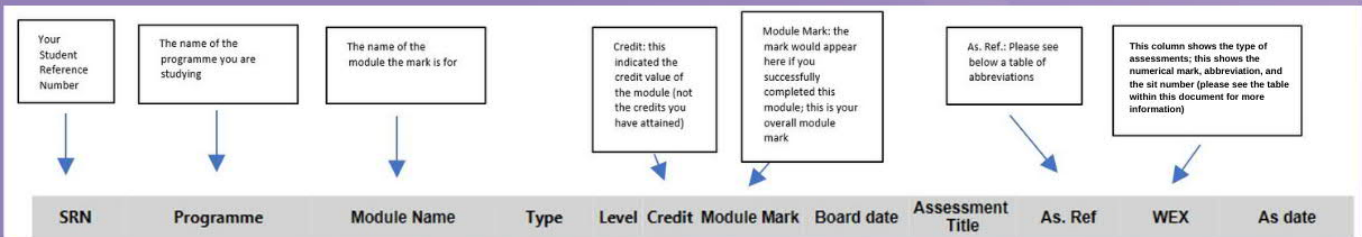


How to read my results



- Example of a single module result release:

Please note that each assessment result consists of a **numeric value** (if you sat the assessment), a **code**, and a **sit count number**. The numeric value is between 0 and 100 and if you sat the assessment you will see the mark you achieved.

- Tables of assessment and assessment type codes

Assessment Code	Long Form	Assessment Description
ME	Marks Entry	The student's numeric mark for the assessment, e.g. 71
A	Absence	The student was absent for this sit or did not submit their coursework
D	Deferral	The student has deferred this sit
AP	Appeal	The student was granted an appeal for this sit. This assessment/sit was voided.
EC or MC	Extenuating Circumstances or Mitigating Circumstances	The student was granted extenuating/mitigating circumstances for this sit. This assessment/sit was voided.
C	Condonation	The mark shown has been condoned which means it is treated as a pass (further guide on condonation is available from the HUB/VLE)
WH	Withheld	The mark is withheld
EX	Exemption	The student is exempt from taking this module
